#### J. CONTRIBUTION TO KNOWLEDGE

My works on Stylistics and the Language of Politics have opened up and expanded new areas of research in the field of Linguistic Stylistics, Discourse Analysis and Sociolinguistics. Some of the works have actually addressed the proper utilisation of linguistic resources at lexical, grammatical, phonological, semantic and graphological levels of analysis, and the application of linguistic theories in studying and interpreting various texts and genres, thus advancing knowledge in the fields of Stylistics and Applied Linguistics in general. The papers also contributed to the language of political discourse and rhetoric (see papers 3, 9, 16 and 17). Also, my publications on the linguistic analysis of prose, poetry and political discourse are directly related to some of the core courses offered and taught in the Department of English in Nigerian universities. These publications thus serve as teaching aids and materials for both lecturers and students teaching and learning these core courses (see papers 2, 5, 8, 10, 11, 13, 15 and 19).

In the same vein, some of my publications, especially those on the issue of language use in the Nigerian bilingual speech community, do not only show to the outside world the linguistic culture of the communities, but also reveal the socio-political diglossic functions of languages in the bilingual speech communities in the Nigerian society at large (see papers 10, 11 and 22). Furthermore, some of my papers expose to the whole world, not only the use of the English Language in the non-native environment, but they also account for the preponderance of features of Nigerian English and non-native varieties of English in general, (see papers 10, 11, 20 and 22). In addition, a reasonable number of my papers on stylistic analysis of texts reveal how linguistic devices are deployed in various texts to advance communication strategies (see papers 22, 23, 24 and 25).

My doctoral research on lexical analysis of Nigerian military Heads of State's political speeches contributes immensely to exposing the method of analysing political

discourses from lexical dimension and shows the strength and power of lexemes in military politics (see paper 1). Equally, all my published works have further enhanced the study on practical application of linguistic theories and procedures to the analyses and interpretations of texts of various kinds. Some of the works, especially those on the use, teaching and learning of the English Language, have helped to project the methods of teaching and learning of the Language in Nigeria and the world at large (see papers 6, 8, 12, 13, 15, 22 and 25).
